Charles was asked about the mainline that they are moving due to the highway construction. The bore has been made, doing a tap tomorrow and will flush the line, have to have 2 good bac t samples prior to hooking up to Town line. Town could potentially be out of flow from 4-5 hours. We may have some discoloration of water, higher chlorine content, may have some air in the line. The plan is to flush the first hydrant when hooked up to keep the air from coming into the Town lines.

Wastewater Report:

Continued cleaning around edges of ponds, reset aerator in first pond several times. Jason spoke about the irrigation field sprinklers that some have some issues and they need to be turned off tomorrow to allow the irrigation field to dry out some. There is a sinkhole that is running over the main sewer line that goes into the lift station, we are working on getting quotes to get someone out here to determine where our issue is and why there is a sinkhole developing. May need to get a pump to bypass the lift station and pump out of the manhole and directly into the lagoons.

**New Business:** 

We received an email stating that we have received a REAP Grant in the total amount requested. The lagoon task force will need to set regular meetings with Wade and set a time line for this project.

Discussion took place about the light at the entrance to Town and Charles mentioned that they are trying to put a flashing light out at the highway that goes off when the fire trucks pull up and roll out on a call.
