### **RESOLUTION 2024-02**

A Resolution Establishing Use of Fireworks within the Municipality of Coyle Oklahoma.

WHEREAS, the 4<sup>th</sup> of July is a commemorative date for the United States; and

WHEREAS, the Town of Coyle encourages all citizens to participate in the annual observance of our Declaration of Independence; and

WHEREAS, the use of fireworks is a traditional method of celebration on the 4th of July; and

WHEREAS, public safety is a basic function of Oklahoma municipalities;

NOW THEREFORE BE IT RESOLVED by the governing board of the Town of Coyle as follows, concerning the use of fireworks within the town limits:

- 1. Fireworks may be used within the town limits for 10 days prior to the holiday ending on July 7<sup>th</sup>.
- 2. Fireworks may be used Sunday through Thursday until 10:00 pm and Friday and Saturday until 12:00 am.
- 3. Use of fireworks in a manner that endangers public safety is not approved at any time whether in conjunction with the July 4<sup>th</sup> celebration or during other times.

### ORDINANCE NO. 2023-02

AN ORDINANCE OF THE TOWN BOARD OF TRUSTEES OF THE TOWN OF COYLE, OKLAHOMA, AMENDING CHAPTER 1, ARTICLE 5, SECTION 1-10 OF THE COYLE MUNICIPAL CODE, ENTITLED "CONSULTING ATTORNEY EMPLOYED"; PROVIDING FOR THE TOWN ATTORNEY, DUTIES, RIGHT TO CONSULT TOWN ATTORNEY AND PAYMENT FOR SERVICES; REPEALER; SAVINGS; SEVERABILITY; CODIFICATION.

### **ORDINANCE**

### BE IT ORDAINED BY THE TOWN BOARD OF TRUSTEES OF THE TOWN OF COYLE, OKLAHOMA:

Chapter 1: Article 5., Sections 1-10 of the Coyle Municipal Code is hereby amended to read as follows:

### **Article 5. Consulting Attorney**

### Section I. 1-10 CONSULTING ATTORNEY EMPLOYEED

- A. Town Attorney Appointed. The Town Board of Trustees may appoint a Town Attorney by majority vote of all the trustees of the Town Board. The Town Attorney may be removed by a majority vote of all the trustees of the Town Board. The Town Attorney may receive a fixed monthly compensation or may work on an hourly basis or in such other manner determined appropriate by the Town Board
- B. Duties of the Town Attorney. The Town Attorney shall have such qualifications, powers, and duties as are prescribed by law. It shall be the Town Attorney's duty to advise the Town Board of Trustees and each member thereof upon all legal questions and the Town Attorney shall give opinions in writing when requested and shall represent the Town as counsel in all litigation, in all courts and shall perform such other legal services on behalf of the Town, its officers or employees, as may be required by the Town Board of Trustees.
- C. Budget; Right to Consult. A budget item shall be established and monies appropriated in an amount necessary to pay the fees and costs of the Town Attorney for each fiscal year. Each trustee shall have an individual right of access to consult with, pose questions, request opinions and direct the work of the Town Attorney, provided the cost of such work of the Town Attorney does not exceed the budgeted and appropriated amount set aside for such purpose. Such right of access to the Town Attorney shall be co-equal and may be exercised by any individual trustees at any time, provided all such work must be related to town business. All work of the Town Attorney shall be provided to all trustees for their review and consideration.

<u>Section II.</u> REPEALER. All ordinances or parts thereof which are inconsistent with this ordinance are hereby repealed.

<u>Section III</u>. SAVINGS CLAUSE. Nothing in this ordinance hereby adopted shall be construed to affect any suit or proceeding now pending in any court, or any rights acquired, or liability incurred nor any cause or causes of action accrued or existing, under any act or ordinance repealed hereby. Nor shall any right or remedy of any character be lost, impaired, or affected by this ordinance.

Section IV. SEVERABILITY. If any one or more of the sections, sentences, clauses or parts of this ordinance, chapter or section shall for any reason be held invalid, the invalidity of such section, clause or part shall not affect or prejudice in any way the applicability and validity of any other provision of this ordinance. It is hereby declared to be the intention of the Town Board of Trustees of the Town of Coyle that this section of the Coyle Municipal Code would have been adopted had such unconstitutional, illegal, or invalid sentence, clause, section, or part thereof not been included herein.

<u>Section V</u>. CODIFICATION. This ordinance shall be codified as shown in Chapter 1 of the Coyle Municipal Code.
