ORDINANCE NO. 2023-02

AN ORDINANCE OF THE TOWN BOARD OF TRUSTEES OF THE TOWN OF COYLE, OKLAHOMA, AMENDING CHAPTER 1, ARTICLE 5, SECTION 1-10 OF THE COYLE MUNICIPAL CODE, ENTITLED "CONSULTING ATTORNEY EMPLOYED"; PROVIDING FOR THE TOWN ATTORNEY, DUTIES, RIGHT TO CONSULT TOWN ATTORNEY AND PAYMENT FOR SERVICES; REPEALER; SAVINGS; SEVERABILITY; CODIFICATION.

ORDINANCE

BE IT ORDAINED BY THE TOWN BOARD OF TRUSTEES OF THE TOWN OF COYLE, OKLAHOMA:

Chapter 1: Article 5., Sections 1-10 of the Coyle Municipal Code is hereby amended to read as follows:

Article 5. Consulting Attorney

Section I. 1-10 CONSULTING ATTORNEY EMPLOYEED

- A. Town Attorney Appointed. The Town Board of Trustees may appoint a Town Attorney by majority vote of all the trustees of the Town Board. The Town Attorney may be removed by a majority vote of all the trustees of the Town Board. The Town Attorney may receive a fixed monthly compensation or may work on an hourly basis or in such other manner determined appropriate by the Town Board
- B. Duties of the Town Attorney. The Town Attorney shall have such qualifications, powers, and duties as are prescribed by law. It shall be the Town Attorney's duty to advise the Town Board of Trustees and each member thereof upon all legal questions and the Town Attorney shall give opinions in writing when requested and shall represent the Town as counsel in all litigation, in all courts and shall perform such other legal services on behalf of the Town, its officers or employees, as may be required by the Town Board of Trustees.
- C. Budget; Right to Consult. A budget item shall be established and monies appropriated in an amount necessary to pay the fees and costs of the Town Attorney for each fiscal year. Each trustee shall have an individual right of access to consult with, pose questions, request opinions and direct the work of the Town Attorney, provided the cost of such work of the Town Attorney does not exceed the budgeted and appropriated amount set aside for such purpose. Such right of access to the Town Attorney shall be co-equal and may be exercised by any individual trustees at any time, provided all such work must be related to town business. All work of the Town Attorney shall be provided to all trustees for their review and consideration.

<u>Section II.</u> REPEALER. All ordinances or parts thereof which are inconsistent with this ordinance are hereby repealed.

<u>Section III</u>. SAVINGS CLAUSE. Nothing in this ordinance hereby adopted shall be construed to affect any suit or proceeding now pending in any court, or any rights acquired, or liability incurred nor any cause or causes of action accrued or existing, under any act or ordinance repealed hereby. Nor shall any right or remedy of any character be lost, impaired, or affected by this ordinance.

Section IV. SEVERABILITY. If any one or more of the sections, sentences, clauses or parts of this ordinance, chapter or section shall for any reason be held invalid, the invalidity of such section, clause or part shall not affect or prejudice in any way the applicability and validity of any other provision of this ordinance. It is hereby declared to be the intention of the Town Board of Trustees of the Town of Coyle that this section of the Coyle Municipal Code would have been adopted had such unconstitutional, illegal, or invalid sentence, clause, section, or part thereof not been included herein.

<u>Section V</u>. CODIFICATION. This ordinance shall be codified as shown in Chapter 1 of the Coyle Municipal Code.

ORDINANCE NO. 2023-03

"AN ORDINANCE REPEALING CHAPTER 1, OFFICERS AND EMPLOYEES, ARTICLE 5, CONSULTING ATTORNEY, SECTION 1–10 CONSULTING ATTORNEY EMPLOYED, OF THE TOWN OF COYLE, CITY ORDINANCES PERTAINTING TO THE TOWN ATTORNEY, MORE PARTICULARLY DESCRIBED HEREIN, AND DECLARING AN EMERGENCY"

WHEREAS, the hiring of a Town Attorney is covered under Chapter 1, Officers and Employees; Article 5, Consulting Attorney, Section 1-10, of The Town of Coyle, City Ordinances; requiring the Town Attorney to be compensated under a fixed monthly compensation agreement for the performance of ordinary services, including counseling and advising the members of the Town Board and all Town officials on all matters of legal nature pertaining to the business of the Town of Coyle;

WHEREAS, the Statutory Town form of government is the only 1 of 4 statutory forms of municipal government that does not have to have a municipal attorney;

WHEREAS, an ordinance is a law, when it comes to internal expectations regarding job duties and compensation, these matters are not typically codified as laws;

WHEREAS, it is the intent of the Board to have the flexibility to determine the services required by the Town and manage the compensation of those services under an engagement agreement;

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF COYLE, STATE OF OKLAHOMA:

"Article 5, Section 1-10, under Chapter 1, of the Town of Coyle, City Ordinances be hereby repealed.
