The families that were helped were families that were nominated from within our school district. One comment that has been made is that people didn't know that we were having it. Advertising is an issue that we have had. On top of the cash donations, we had lots of items donated such as 5 roasts and hams, cookie baskets, the new coffee shop donated refreshments and the Assembly of God church made cookies for cookie decorating.

The general fund blanket purchase order was lowered a few months ago down to \$250.00. Since that time, we have spent almost all of the \$250.00 each month due to expenses that have come up for supplies needed. Dusty suggested that we create a maintenance blanket purchase order of \$250.00

specifically for maintenance supplies.

**Emergency Management Report:** 

Carl went on 1 call, an accident. We have ordered the equipment needed. The siren works. We will start testing it once a month as we were doing before. SignalTech suggested that during the extreme cold, if we don't have to use it don't. It has been fixed and run through a full cycle. We have not received an invoice from them at this time. We had been testing the siren on the second Monday of the month. Dusty stated he doesn't mind continuing to test it while Carl is at work. There was feed back received when we were doing testing of the storm siren. An email was sent when this testing was being done, however, some individuals do not check their email that often and it would be better to send out a text. We will put it in the procedure on testing the siren that a text message will be sent prior to the storm siren testing. Need to send out a message that we will resume testing the storm siren on the 2<sup>nd</sup> Monday of the month.

**New Business:** 

A discussion was had about the weather. It is going to be cold. Carl and Dusty both make sure to stay weather aware through Emergency Management anytime weather moves into our area. Also, ODOT comes and clears off Main Street for us when we get foul weather. We also have a few guys that use their tractors to clear the streets as needed. We use the email/text system to send out alerts as needed when there is weather in Town.

There is an old gas heater hanging on the wall in the shop. The question was asked if there is a gas line running to the shop. We need to keep an eye on the liquids in the shop so that they don't freeze. We might need to get a kerosene heater or we need to winterize the tractor. Some day we need to get a heater and some running water to the shop
