OMAG Insurance:

Dusty called and spoke to someone at OMAG that walked him through the policies. His concerns about it are what is not listed on the policy such as the water tower and the red building. Any property the Town owns is covered, however, there is no coverage on the lagoons. JoAnn stated that we could get coverage on the fence. There are policies available that we could add to the lagoons in case a levy breaks or it overflows due to rain, however there are only a couple of places that hold that type of coverage. The fence perimeter can be measured through Google Earth. Charles thinks the water tower is 120,000 gallons. The lagoons have been there for a long time, they added on in 1998. There is a line that goes north from the lagoons into the field from when they pumped out of it previously. We don't have any idea what the lagoons cost, but we can measure the fence and figure a replacement cost of the fencing around it. They can do an estimate off the cost for the water tower, it may be over \$110,000.00 to replace it. About 80% of Town's insure their water towers. This policy renews on November 1st, so nothing can be approved tonight because we don't know any pricing of things that may need to be added. We need to contact Luckinbill about refurbishing the lift station. We might need to schedule a special meeting to be able to confirm pricing before approval of adding any other properties. Changes that need to be made would be to remove Foley Equipment from the additional named insured. We need to find out if the Water Resources Board needs to be separately named or why they are named insured.

JoAnn found a state statute that she printed out in 2020, stating that individuals that sign checks need to be bonded. She called and spoke to the company that we get the bonds through and he stated that Board members do not need to be bonded because they aren't signing checks. In our case, the Board are who signs all the checks. He suggested that we work with the bank and see if they can implement a stop for any check over a certain amount and get verification before processing. We need to look at the contract we have with the bank. Need to decide what the exposure will be and at what amount the Trustees need to be bonded at, \$10,000 or \$20,000.

OG&E Update:

Dusty talked with OG&E awhile back about the power spikes in Town. The Town was capped at our power usage and they removed the cap for us. Another issue we have is that we have a lot of trees around our power lines. We are on a 4-year cut plan; however, it has been a while since they have done much trimming in our area. Our OG&E rep came out and looked at our trees and saw how bad our tree issue is. The foliage representative also came out and agreed that we have a big tree issue. They are working on creating a plan to come out and trim our trees and get us back on to their 4-year tree trimming plan. Our OG&E rep is continuing to look into the power surges that we are having in the Town. Dusty is working on several different issues with OG&E.

Fire Dept Report: Had 36 calls this month, responded to 81% of them. When the power surges

happen, their system goes down and they are unable to get calls. It has to be manually reset. Participated in the Fall Festival that went really well. Received a donation of 25 cases of water. Maintenance – replaced pump and motor on 23, replaced pump and motor on 25, bed is sitting on the new rescue, replaced transmission line on Command truck, replaced motor again on 23, air line leak on 28, replaced pump battery on brush 21, replaced emergency lighting on Command. Equipment is getting older and starting to wear down. Haven't heard anything about the grants yet. Still haven't gotten the reimbursement

back on the radios from Homeland Security.

Financial Report: These balances are as of the end of September.

General Fund: \$58,673.01

CPWA: \$55,329.09

Fire Department: \$57,827.05

We might need to schedule a different special meeting to discuss street repairs. Quote has been received for the street signs just need to get them ordered.

Maintenance Report: Kevin has been working on a list of stuff that Linde gave him. The Town is

responsible for mowing on Bond from the bleachers down to Triple XXX. He lost the key to the tractor, but the spare we had is in the box. Theses keys can be ordered on Amazon. The tractor has a busted hydraulic line that will need to be

replaced.

Cemetery Report: The cemetery deed was approved by Matt with a couple of minor changes. Mrs.

Arnett came in and purchased the 3 lots that she was wanting to purchase.

There is another gentleman that would like to purchase a lot as well.

We had a really good training with OMAG on the cemetery with people from Langston and Guthrie in attendance as well. There was a suggestion made to contact the University's Engineering department and see if they might need a

project. JoAnn could ask Gharrett who we could talk to about that.

Court Clerk Report: Nothing to report

Emergency Nothing to report. Dusty spoke with Steven Haga who is looking for someone

Management Report: new to come out and look at their sirens. He will pass information along once

he finds someone to take a look at theirs.
