Meeting was called to order at 7:02 pm by Carl Long

Trash Services: After Republic's attorney reached out to our attorney to see why they hadn't heard from us this meeting was scheduled so a few issues could be discussed. We had several citizens that had bulk trash out that was not picked up on our bulk trash pickup day that was scheduled a few weeks ago. According to our contract, all the items that were out should've been picked up. It was stated that there were only 3 houses that Mr. Gilbert was aware of where the trash did not get picked up, however there were more residences than that. Another issue we have had is the dumpsters being placed in the streets. Would like to work together to resolve this issue. Take pictures and create a list of addresses where this is an issue. Republic has had some management turnover and Mr. Gilbert has just taken over Oklahoma. There is new management in place at the Stillwater location. Another issue that we have had is the trash not being picked up due to weather. Mr. Gilbert stated that if the trash could not be serviced on the day it is supposed to be, it will be serviced the next day or two as weather allows. If we require gravel to be put where the dumpster should be placed, how would we make sure that happened. For bulk pickup, the Board likes the idea of placing two roll-off dumpsters in Town and having citizens dispose of their bulk trash there instead of curbside bulk pickups. Possibly have kids from FFA go around and pick up bulk trash for individuals that

are unable to do it themselves. Mr. Gilbert and the Board discussed and agreed that the contract would need to have more definitive language specifying what they will pick up for bulk items. The Board is interested in the 5-year contract if we are able to fix the issues that have been mentioned this evening. The Board would like to have a draft of a contract to send to Matt Devlin for review. Mr. Gilbert will have for us an updated RFP by the end of next week. Can do better on pricing if we do the roll offs instead of the curbside bulk pickup which would still be three times annually. At some point Republic will be doing an audit out here. Dumpsters need to be on stable flat ground. Would like to get a spec sheet for them. Would like to remove the bin lock charge at the Fire Department as lock is no longer there. Need to get a count of broken polycarts and have them replaced with good ones to replace for our citizens as needed.
